The basic motive is to empower the students to face the challenges of life with courage and commitment.

UCCI & MJC have agreed for this mutual association and hereinafter contained, the UCCI will provide Industrial Visits, Consultancy and Job Training Services and play an effective role in uplifting the professional skills and personality of the students of MJC.

1. PROPOSED MODE

The UCCI will provide the consultancy and Job training services using online tools / visit and by all or any of the following manner: -

- I. Conducting seminars/ conferences/ workshop.
- II. Conducting personality development and communication skill programmes.
- III. Conducting online job interview trainings programmes.
- IV. Grooming classes for students and faculties both.
- V. Promoting mutual faculty exchange for academic growth.
- VI. Mutual visits of academic staff.
- VII. Exchange of academic resources and other information.
- VIII. Training and development of administrative and technical staff.
- IX. Organizing combined national & international events.

2. EFFECTIVE DATES AND AMENDMENTS

- I. This MOU shall take effect upon signing by both parties and shall remain in effect for a period of 5 years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.
- II. The MOU may be renewed at the end of this period by mutual written agreement by both parties.
- III. The provision of this MOU may only be amended or waived by mutual agreement by both parties.
- IV. Any party may terminate this MOU and any related agreement for reason by giving thirty (30) days prior written notice to the other party.


3. RELATIONSHIP

Nothing in this MOU shall be constructed to make either party, a partner, an agent or legal representative of the other for any purpose.
