

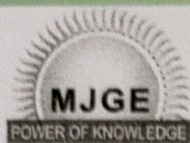

PURPOSE OF THE MOU

The main purpose of this MOU is to provide Medical Facilities to the staff members and students of MJC by the Sparsh Hospital in concession rate.

SCOPE

WHEREAS the **Sparsh Hospital** is engaged in providing medical facilities in Bhilai and it is known as multispecialty hospital. It is well known for its infrastructure and specialist doctor available.

WHEREAS the M J College is a premier reputed institution dedicated for the promotion of education, culture and human values providing a unique learning experience which will enable the students to realize their innate potential and mold their overall personality. The basic motive is to empower the students to face the challenges of life with courage and commitment.

Sparsh hospital and M J College has agreed for this mutual association and hereinafter contained, the Sparsh Hospital will provide medical facilities as concession rate to the staff members and the students of MJC.

1. PROPOSED MODE

The **Sparsh Hospital** will provide a special discount of 15% on OPD consultation payable by the patient, 10% IPD Credit except medicines, bedside procedures, implants, consumables to the staff members of MJC. Important dates of medical observations will be celebrated together in forms of awareness programmes.

2. EFFECTIVE DATES AND AMENDMENTS

1. This MOU shall take effect upon signing by both parties and shall remain in effect for a period of 5 years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.

- II. The MOU may be renewed at the end of this period by mutual written agreement by both parties.
- III. The provision of this MOU may only be amended or waived by mutual agreement by both parties.
- IV. Any party may terminate this MOU and any related agreement for reason by giving thirty (30) days prior written notice to the other party.
- V. All the IPD Credit bills will be cleared within 45 days of the submission of the bills.

3. RELATIONSHIP

Nothing in this MOU shall be constructed to make either party, a partner, an agent or legal representative of the other for any purpose.
