(Herein jointly referred as parties and singularly as a Party)


Whereas the second party submitted a proposal to First party to promote education related to Banking, Financial services, Stock Market etc through Certified Financial Planner an international certification especially for banking and Financial services on the basis of understanding set out in this memorandum of Understanding (MOU).

### 1. Areas of responsibility and cooperation of both parties.


The parties agree to collaborate in the following areas.

- i. The students of first party would be offered certification program and courses in Certified Financial Planner by the second party.
- ii. The first party would arrange students for the course to be offered by the second party and the second party would arrange course material and faculties at their own cost.
- iii. The quality of training and delivery shall be monitored by the first party.


2. **The Collaboration Team.** The parties appoint representative to manage and oversee the collaborative activities contemplated under this MOU.



3. **INFRASTRUCTURE AND RESOURCES.** The second party will use its infrastructure for conducting the classes. The infrastructure of first party can also be used for convenience of students. The second party will not create any financial burden on first party in any form.
4. **Students:** The first party will mobilize the required number of students' i.e around 20 students to have financial feasibility and will also support in collecting fee from the students. The first party will provide a list of part participating students to Second party.
5. **Course to be covered.** The second party will cover the certification course for **Certified Financial Planner**. The second party will also arrange the registration students and all related follow up with Financial Planning Standard Board.
6. **Fees and Payment Schedule.** A tuition fee of Rs.45000/- shall be payable by each student. For the ease of students it is also agreed that the students can pay the fees in four installments i.e . Rs. 15000/- at the time of starting course and Rs.10000/- in the subsequent three months. The registration fee with board and examination fee shall be extra in actual as declared by the Board. No extra payment shall be charged from the students for study materials and online access.
7. **Continued support to students:** In the event of any student not able to clear the paper in first attempt shall be provided coaching for Two more attempts without charging any fees.
8. **PLACEMENT:** The second party will organize the placement of students clearing the certification.




9. **Amendments:** The terms of MOU may be amended any time by mutual consent of parties.


10. **Term:** The MOU shall remain effective till it is terminated by the parties.




