



MEMORANDUM OF UNDERSTANDING (MOU)

1. PURPOSE OF THE MOU

3. EFFECTIVE DATES AND AMENDMENTS

- I. This MOU shall take effect upon signing by both parties and shall remain in effect for a period of Five (5) years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.
- II. The MOU may be renewed at the end of this period by mutual written agreement by both parties.
- III. The provision of this MOU may only be amended or waived by mutual agreement by both parties.
- IV. Any party may terminate this MOU and any related agreement for reason by giving thirty (30) days prior written notice to the other party.


4. RELATIONSHIP




