



MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

AND

INTERNAL QUALITY ASSURANCE CELL (IQAC), M. J. COLLEGE, BHILAI

The agreement made and entered into on 2nd day of April 2018 between "SHRI SHANKARACHARYA MAHAVIDYALAYA, BHILAI NAGAR (hereinafter referred as SSMV) situated at Bhilai Nagar, Durg, Chhattisgarh, India and INTERNAL QUALITY ASSURANCE CELL (IQAC), M. PURPOSE OF THE MOU

1. PROPOSED MODE OF COLLABORATION

- I. Participation in seminars, conferences, workshop and trainings.
- II. Promoting mutual faculty exchange for academic growth.
- III. Mutual visits of academic staff.
- IV. Exchange of academic resources and other information.
- V. Training and development of administrative and technical staff.
- VI. Exchange of students.
- VII. Organizing combined national & international events.

3. EFFECTIVE DATES AND AMENDMENTS

- I. This MOU shall take effect upon signing by both parties and shall remain in effect for a period of Five (5) years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.
- II. The MOU may be renewed at the end of this period by mutual written agreement by both parties.
- III. The provision of this MOU may only be amended or waived by mutual agreement by both parties.
- IV. Any party may terminate this MOU and any related agreement for reason by giving thirty (30) days prior written notice to the other party.

4. RELATIONSHIP

Nothing in this MOU shall be constructed to make either party, a partner, an agent or legal representative of the other for any purpose.
